#### 1 THE PROMOTER

- 2.3 Entry is by purchasing any item from the Smoke & Barrels Food Menu and completing the required entry information including (but not limited to) Name, Email Address, Phone Number. All fields must be completed for entry to be valid.
- 2.4 The Promoter's decision is final and no correspondence will be entered into.

## 7 COLLECTION NOTIFICATION STATEMENT
