Terms and Conditions

1 THE PROMOTER

2 ENTRY

2.1 Entry is \$20 & only open to residents of Australia 18 years and over.

2.2 Employees and the immediate families of the Promoters, directors, management, related companies, retailers, suppliers and their agencies associated with this promotion are ineligible.

2.3 Individuals gain entry by paying \$20 to Northies Cronulla Hotel before or before round 3 of the 2021 NRL season (28th March 2021)

2.4 Every individual entrant must come in venue to sign up and must show valid form of ID upon sign up.

2.5 Entrants can only place tips for themselves. Should entrants be caught placing tips on behalf of others they will forfeit their prize winnings (both for individual rounds and major prize)

2.6 The competition is run through Sportspick, a venue sponsored tipping promotion system.

2.7 The Promoter's decision is final and no correspondence will be entered into.

2.8 The Promoter reserves the right in its sole discretion to disqualify any individual who the Promoter has reason to believe has breached any of these terms and conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. 3.1 The competition will commence on Thursday 11th March 2021 and run until Sunday 3rd October 2021 (NRL Grand Final)

3.2 The winners will be notified by Northies Cronulla Management by Friday 8th October 2021.

4.1 There will be 4 x winners. 1st place, 2nd place, 3rd place and last place.

4.2 The Promoter reserves the right to request winners to provide proof of identity, proof of residency, proof of age at the nominated prize delivery address and/or proof of entry validity (including phone bill) in order to claim a prize. Proof of identification, residency, age and entry considered suitable for verification is at the discretion of the Promoter. In the event that a winner cannot provide suitable proof, the winner will forfeit the prize in whole and no substitute will be offered.
